LETTER FROM THE BOARD CHAIR

Generations FCU is deeply rooted in San Antonio, founded in 1940 by public servants with a mission to serve the community that built us. This year, we've taken that commitment even further, making a collective impact that's building momentum for a stronger future.

We kicked off 2023 celebrating our local heroes on National Law Enforcement Appreciation Day, delivering treats to the incredible men and women of the San Antonio Police Department, Castle Hills Police Department, and Balcones Heights Police Department. These dedicated officers, staff, and dispatchers keep our streets safe every day.

The year got even sweeter with our participation in the 2023 San Antonio Sports Corporate Cup. Not only did our teams have a blast competing, but we also emerged as fundraising champions. Thanks to our members and volunteers, we raised a staggering \$57,528 for essential local organizations like the SA Food Bank, Haven for Hope, and the Boys & Girls Clubs of San Antonio. This achievement marks our fourth consecutive Charity Challenge Championship win, a testament to our unwavering commitment to giving back.

Summer brought another opportunity for Generations FCU to make a difference. Partnering with Communities in Schools of San Antonio's Stuff the Bus campaign, we collected an impressive 4,121 school supplies and a \$3,580 cash donation. Thanks to the generosity of our branch teams, members, and volunteers, we were recognized as the top donor in the medium-size business category.

Fall presented some friendly competition among our branches as they creatively raised funds for the Leukemia & Lymphoma Society through bake sales, homemade meals, and gift baskets. We proudly walked for LLS Light the Night at Hemisfair Park and raised a record-breaking \$33,492 for this important cause.

Every year we launch the holiday season with Turkey Express, continuing our tradition of providing Thanksgiving meals to fire stations, police stations, and sheriff's offices throughout San Antonio. This is our way of saying "thank you" to the men and women in uniform who keep our community safe as we celebrate with our families. In November and December, we also partnered with the SA Fire Department's Santa's Firefighter Toy Drive, Ma Hila's Heart, and Boysville, Inc., to bring smiles to children across our city.

Looking back at 2023, we're filled with immense pride. Together, we raised a grand total of \$343,419.13, combining financial contributions and volunteer hours dedicated to numerous local organizations. Our dedicated #GFCUCares Team logged an impressive 953.25 volunteer hours, serving community-serving nonprofits large and small that help improve the lives of people throughout our community.

These achievements wouldn't be possible without our incredible members, employees, and partner organizations. Together, we're making waves in San Antonio. We extend our sincere gratitude to our member-owners – your membership fuels these positive changes. LETTER FROM THE SUPERVISORY COMMITTEE

The Supervisory Committee is tasked with overseeing independent audits of the Credit Union to ensure that member funds are managed appropriately and that assets are safeguarded. Additionally, the Supervisory Committee evaluates the effectiveness of internal controls and makes recommendations for improvement, ensures annual financial statement audits, and verifies member accounts. The committee is established by law and is an integral part of ensuring the credit union's operational process and fiscal soundness on behalf of its member owners.

Each year, the Credit Union undertakes two independent reviews. In 2023, Generations FCU's Vice President of Risk Management, Erica Garza worked with an independent auditor on the execution of an audit, and with the National Credit Union Administration on a comprehensive exam. The findings of these reviews confirmed that we are a secure financial institution which continues to operate in an optimized manner.
